NUMBER 3/PUU-VII/2009

FOR THE SAKE OF JUSTICE UNDER THE ONE ALMIGHTY GOD

THE CONSTITUTIONAL COURT OF THE REPUBLIC OF INDONESIA

[1.1] Examining, hearing, and deciding upon constitutional cases at the first and final level, has passed a decision in the case of Petition for Judicial Review of Law Number 10 Year 2008 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly against the 1945 Constitution of the State of the Republic of Indonesia, filed by:

IP, S.H., Irhamsyah, S.H., David Marshala Aruan, S.H., M.H., Albert Nadaek, S.H., Drs. Jack Sidabutar, S.H., M.H.,

M.M. All of whom are Advocates incorporated in the Advocacy Team for Constitutional State as well as the Advocacy Team for People's Aspiration and Voice, selecting their legal domicile at Jalan Pangeran Diponegoro Number 74, Central Jakarta;

Hereinafter referred to as ----- **the Petitioners**;

[1.3] Having read the Petitioners' petition;

Having heard the Petitioners' statement;

Having heard the statement of the Government;

Having heard and read the written statement of the People's Legislative Assembly;

Having heard the statement of the Experts of the Petitioners and the Government;

Having examined the evidence presented by the Petitioners;

Having read the conclusion of the Petitioners and the Government;

3. LEGAL CONSIDERATIONS

[3.1] Considering whereas the objective and purpose of the petition is to review the constitutionality of Article 202 paragraph (1) of Law Number 10 Year 2008 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly (State Gazette of the Republic of Indonesia Year 2008 Number 51, Supplement to the State Gazette of the Republic of Indonesia Number 4836, hereinafter referred to as Law 10/2008) against the 1945 Constitution of the Republic of Indonesia (hereinafter referred to as the 1945 Constitution);

[3.2] Considering whereas prior to considering the Principal Issue of the Petition, the Constitutional Court (hereinafter referred to as the Court) shall first consider two matters, namely as follows:

- The authority of the Court to examine, hear, and decide upon the *a quo* petition;
- The legal standing of the Petitioners to file the *a quo* petition;

With respect to the foregoing two matters, the Court is of the following opinion:

Authority of the Court

[3.3] Considering whereas one of the constitutional authorities of the Court under Article 24C paragraph (1) of the 1945 Constitution which is also reaffirmed in Article 10 paragraph (1) sub-paragraph a of Law Number 24 Year 2003 regarding Constitutional Court (State Gazette of the Republic of Indonesia Year 2003 Number 98, Supplement to the State Gazette of the Republic of Indonesia Number 4316, hereinafter referred to as the Constitutional Court Law) *juncto* Article 12 paragraph (1) sub-paragraph a of Law Number 4 Year 2004 regarding Judicial Power (State Gazette of the Republic of Indonesia Year 2004 Number 8, Supplement to the State Gazette of the Republic of Indonesia Number 4359) is to conduct judicial review of law against the 1945 Constitution;

[3.4] Considering whereas the *a quo* petition concerns with the judicial review of law against the 1945 Constitution, *in casu* Law 10/2008 against the 1945 Constitution, the Court therefore has the authority to examine, hear, and decide upon the *a quo* petition;

Legal standing of the Petitioners

[3.5] Considering whereas under the provision of Article 51 paragraph (1) of the Constitutional Court Law along with its elucidation, parties who may file a petition for the judicial review of law against the 1945 Constitution shall be those who deem that their constitutional rights and/or authorities have been impaired by the coming into effect of a law, namely:

- a. individual Indonesian citizens (including a group of people having similar interests);
- b. customary law community units insofar as they are still in existence and in line with the development of the communities and the principle of the Unitary State of the Republic of Indonesia as set forth in law;
- c. public or private legal entities; or
- d. state institutions;

Hence, the Petitioners in the judicial review of law against the 1945 Constitution must explain and substantiate the following:

- a. their legal standing pursuant to the aforementioned four categories;
- b. the impairment of constitutional rights and/or authorities granted by the 1945 Constitution by the coming into effect of the law being petitioned for review;

[3.6] Considering whereas with regard to the impairment of constitutional rights and/or authorities as intended in Article 51 paragraph (1) of the Constitutional Court Law, the Court following Decision Number 006/PUU-III/2005 dated May 31, 2005 and Decision Number 11/PUU-V/2007 dated September 20, 2007 is of the opinion that the impairment of constitutional rights and/or authority as intended in Article 51 paragraph (1) of the Constitutional Court Law must meet five criteria, namely:

- a. there are constitutional rights and/or authority granted by the 1945 Constitution;
- b. such constitutional rights and/or authority are impaired by the coming into effect of the law petitioned for review;
- c. the impairment of such constitutional rights and/or authority is specific and actual or at least potential in nature which, pursuant to logical reasoning, will take place for sure;
- d. there is a causal relationship (*causal verband*) between the impairment of constitutional rights and/or authority and the law petitioned for review;
- e. there is a possibility that by the granting of such petition, the impairment of such constitutional rights and/or authority argued by the Petitioners will not or does not occur any longer;

[3.7] Considering whereas the Petitioners consist of three Groups of Petitioners, where Petitioner Group I includes 11 Political Parties Participating in the 2009 General Election (hereinafter referred to as the Political Parties Participating in the General Election), Petitioner Group II consists of Candidate Members of the People's Legislative Assembly from the foregoing eleven Political Parties Participating in the General Election, and Petitioner Group III is the Members of the Political Parties Participating in the General Election concerned, who argue as follows:

[3.7.1] Whereas the Petitioner Group I claims itself as a legal entity having obtained the status as legal entity from the Minister of Law and Human Rights, the Petitioner Group II and the Petitioner Group III claim themselves as individual Indonesian Citizens (included as a group of people having similar interests);

[3.7.2] Whereas the Petitioner Group I, Petitioner Group II, and Petitioner Group III deem that the constitutional rights granted by Article 1 paragraph (2) and paragraph (3), Article 27 paragraph (1), Article 28D paragraph (1) and paragraph (3), as well as Article 28I paragraph (2) of the 1945 Constitution have been impaired by the coming into effect of Article 202 paragraph (1) of Law 10/2008 which reads, *“Political Party Participating in the General Election shall be obligated to fulfill the threshold of vote acquisition of at least 2.5% (two point five percent) of the total valid votes at national level so as to be involved in the determination of seat acquisition in the People’s Legislative Assembly”* (known as “parliamentary threshold” or PT). After the revision to articles related to Parliamentary Threshold, namely Article 203 paragraph (1), paragraph (2), and paragraph (3), Article 205 paragraph (1) paragraph (2), paragraph (3), paragraph (4), paragraph (5), paragraph (6) and paragraph (7), and Article 206, Article 207, Article 208, as well as Article 209 of Law 10/2008, for the following reasons:

- a. Whereas articles of the *a quo* Law 10/2008 reflect the violations to the principle of constitutional state and human rights;
- b. Whereas according to the Petitioners, the provision of Article 202 paragraph (1) of Law 10/2008 which only stipulates the requirement of

threshold for legislative seats at national level (People's Legislative Assembly), rather than for the determination of seats in the Regional People's Legislative Assembly as set forth in the provision of Article 202 paragraph (2) of Law 10/2008 which reads, "*The provision as intended in paragraph (1) shall not apply for the determination of seat acquisition in the Regional People's Legislative at province level and the Regional People's Legislative at regency/municipality level*" has led to the discrimination of position and treatment as well as legal uncertainty and injustice suffered by the Petitioners;

- c. Whereas as a result of the policy on the threshold for vote acquisition, some members of the People's Legislative Assembly obtain seats with lesser total votes in an Electoral District because their political parties fulfill the Parliamentary Threshold (PT), while other candidate members of the People's Legislative Assembly who have acquired more votes do not obtain any seats since their political party do not fulfill the Parliamentary Threshold, hence it gives rise to injustice and impairs the constitutional rights of the candidate members of the People's Legislative Assembly nominated by political parties which do not fulfill the Parliamentary Threshold;
- d. Whereas the *a quo* provision violates the principle of people's sovereignty, namely that it will lead to the loss of millions of votes from the voters of members of the People's Legislative Assembly acquired by the Political

Parties Participating in the General Election which do not fulfill the requirement of Parliamentary Threshold. This has indirectly impair the constitutional rights of the members of the related Political Parties Participating in the General Election as voters;

- e. Whereas the rationality of the *a quo* article is unclear, so that it is discriminatory in nature;

[3.8] Considering whereas with regard to the foregoing arguments of the Petitioners concerning legal standing, the Court is of the following opinion:

- a. Whereas the Petitioner Group I have the legal standing as Petitioners of legal entity in accordance with Exhibit P-6, Exhibit P-6A, Exhibit P-7, Exhibit P-8, Exhibit P-9, Exhibit P-10, Exhibit P-11, Exhibit P-12, Exhibit P-29, and Exhibit P-30, the Petitioner Group II have also fulfilled the requirement as Petitioners of individual Indonesian citizen Petitioners of candidate members of the People's Legislative Assembly from the Political Parties Participating in the General Election based on Exhibit P-13. The Petitioner Group III who argue themselves as petitioners of individual Indonesian citizensof members of the Political Parties Participating in the 2009 General Election fails to present evidence of their membership cards of the related Political Parties, hence the Petitioner Group III do not fulfill the requirement as Petitioners in the *a quo* petition;

- b. Whereas the assumption of the Petitioners, *in casu* the Petitioner Group I and Petitioner Group II concerning the impairment of their constitutional rights granted by the 1945 Constitution by the coming into effect of Articles of Law 10/2008 being petitioned for review, is potential in nature, has causal relationship, and surely will not take place if the petition being argued is granted;
- c. Whereas hence, *prima facie* the Petitioner Group I and the Petitioner Group II fulfill the requirement of legal standing as stipulated in Article 51 paragraph (1) of the Constitutional Court Law and Decision Number 006/PUU-III/ 2005 dated May 31, 2005 and Decision Number 11/PUU-V/2007 dated September 20, 2007;

[3.9] Considering whereas since the Court has the authority to examine, hear and decide upon the *a quo* petition and that several Petitioners have legal standing, the Court shall further consider the Principal Issue of the Petition;

Principal Issue of the Petition

[3.10] Considering whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 along with the related Articles, namely Article 203 and Article 205, Article 206, Article 207, Article 208, and Article 209 of Law 10/2008 are contradictory to Article 1 paragraph (2) and paragraph (3), Article 27 paragraph (1), Article 28D paragraph (1) and paragraph (3), as well as Article 28I

paragraph (2) of the 1945 Constitution for reasons which principally are as follows:

- a. The *ratio legis* of Article 202 paragraph (1) as well as its consistency with the principle of democracy and Human Rights are unclear. It also violates the principle of constitutional state as set forth in Article 1 paragraph (3) of the 1945 Constitution. This also means that the *a quo* is irrational, so as to be discriminatory in nature (contradictory to Article 28I paragraph (2) of the 1945 Constitution);
- b. The *a quo* article has resulted in the loss of votes and aspiration of the citizens, namely the aspiration of the citizens who have selected the Political Parties Participating in the General Election that do not fulfill the Parliamentary Threshold, as their votes automatically become invalid, which means that it has violated the principle of people's sovereignty as set forth in Article 1 paragraph (2) of the 1945 Constitution;
- c. The *a quo* article has caused the loss of equal opportunity for citizens in the government, since the Legislative Candidate Members from the Political Parties which do not fulfill the Parliamentary Threshold do not obtain seats in the People's Legislative Assembly even though in the same Electoral District their votes are higher than those of the Legislative Candidate Members from the Political Parties fulfilling the Parliamentary Threshold. However, Political Parties acquiring lesser votes which fulfill the Parliamentary Threshold obtain seats. Such matter is contradictory to

Article 27 paragraph (1) *juncto* Article 28D paragraph (1) and paragraph (3) of the 1945 Constitution;

- d. Whereas automatically the articles of Law 10/2008 related to Article 202 paragraph (1), namely Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 are also contradictory to the 1945 Constitution for similar reasons;

[3.11] Considering whereas based on the foregoing arguments, the Petitioners presented the following *petitum*:

- a. To declare that Article 202 paragraph (1) of Law 10/2008 is contradictory to the 1945 Constitution;
- b. To declare that Article 202 paragraph (1) of Law 10/2008 does not have binding legal effect;
- c. To declare that Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 of Law 10/2008 are contradictory to the 1945 Constitution and do not have binding legal effect;
- d. To order the publication of the Decision in the Official Gazette of the Republic of Indonesia;
- e. To request for a fair decision to the best possible extent (*ex aequo et bono*);

[3.12] Considering whereas in addition to written evidence supporting the petition, namely Exhibit P-1 through Exhibit P-32, the Petitioners also presented three experts who conveyed statements under oath at the hearing on January 29, 2009 along with written evidence and at the hearing on February 4, 2009 included entirely in the Facts of the Case part, which principally state as follows:

1. Pipit Rochijat Kartawidjaja

- Thresholds in Indonesia is highly exaggerated. There is a threshold of seats in every Electoral District (3-10 seats), threshold of Voter's Denominator, and also the Electoral Threshold (ET) which is subsequently replaced with the Parliamentary Threshold (PT). Other countries generally only apply one threshold. The Parliamentary Threshold is deemed to be incompatible with the purpose or mission of the General Election as included in Law 10/2008, namely proportionality, degree of representativeness, and equity;
- The threshold of 2.5% (two point five percent) is contradictory to Decision Number 22-24/PUU-VI/2008 dated December 23, 2008, because by determining the threshold, the legislative candidate members in an Electoral District will not be elected as their political parties do not fulfill the threshold of 2.5% (two point five percent) at national level, even though the vote acquisition in their Electoral District is greater than the political parties meeting the threshold;

2. Prof. Dr. Philipus Hadjon, S.H.

Article 202 paragraph (1) of Law 10/2008 is irrational and hence it is discriminatory, because it is not in accordance with the provision in Law 10/2008 as the determination of seat acquisition in the Electoral District by political parties Participating in the General Election would be eliminated by the provision of national threshold of 2.5%. The expert also states that it is inappropriate if the provision of the Parliamentary Threshold concerned is deemed as policy option which cannot be assessed by the Court, because arbitrary policy options must be subject to review by a court of law, *in casu* the Court. Hence, according to the expert, Article 202 paragraph (1) of Law 10/2008 is unconstitutional;

3. Dr. Lodewijk Gultom, S.H., M.H.

Article 202 paragraph (1) of Law 10/2008 is contradictory to Human Rights, since it is very prone to discriminate against each citizen obtaining his/her right to vote and disregards the principle of protection as set forth in Law Number 10 Year 2004 regarding the Establishment of Laws and Regulations. Hence, in philosophical, judicial, and sociological manner, Article 202 paragraph (1) of Law 10/2008 is contradictory to the 1945 Constitution;

[3.13] Considering whereas the Court has heard the statement of the People's Legislative Assembly at the hearing on January 29, 2009 as entirely described in the Facts of the Case part, which principally states as follows:

- a. The provision of threshold set forth in Article 202 paragraph (1) of Law 10/2008, for convenience referred to as the Parliamentary Threshold (PT) is a policy option to strengthen the presidential system and to establish a simple party system. This policy option of Parliamentary Threshold is formulated to replace the previous policy option, namely the Electoral Threshold (ET) adopted in the previous Law of General Election which evidently cannot strengthen the presidential system and create simple party system;
- b. As a policy option, the policy concerning the Parliamentary Threshold is not discriminatory because it applies to all political parties participating in the General Election and does not use the term of major political parties or minor political parties prior to the holding of General Election, as everything is submitted to the voters;
- c. In fact, the Parliamentary Threshold policy benefits the political parties Participating in the General Election as they are guaranteed to be able to participate in the following General Election without having to establish a coalition or a new political party as provided for in the policy on Electoral Threshold;

[3.14] Considering whereas the Court has also heard the statement of the Government at the hearing on January 29, 2009 as entirely described in the Facts of the Case part, which principally state as follows:

- The Government refers to the previous Decisions of the Court with regard to various thresholds, whether it is “political parties threshold”, “local leader threshold”, and “electoral threshold”, the connection of which is that in the event that the 1945 Constitution delegates such matter to be set forth with or in a law insofar as it is not discriminatory, such “legal policy threshold” is not contradictory to the 1945 Constitution. In addition, in its several decisions, the Court also refers to Article 28J which allows the existence of restrictions for various citizens’ rights provided that the requirement for such restriction as set forth in Article 28J paragraph (2) of the 1945 Constitution is fulfilled;
- Hence, the policy of “parliamentary threshold” policy as included in Article 202 paragraph (1) of Law 10/2008 which constitutes a policy related to the General Election which is delegated to the legislators by Article 22E paragraph (6) of the 1945 Constitution to regulate it with law is not contradictory to the Constitution, since the *a quo* provision does not contain discriminatory elements bearing in mind that the policy of Parliamentary Threshold applies to all Political Parties Participating in the General Election;

- All of the Court's decisions related to these various threshold policies declare that such legal policies are not contradictory to the 1945 Constitution because they are not discriminatory. It is different from the policy stipulated in Article 316 sub-article d of Law 10/2008 which is deemed by the Court to be discriminatory, so that it is declared as contradictory to the 1945 Constitution and does not have binding legal effect;
- Comparison with the application of threshold in various countries argued by the Petitioners is certainly beneficial, however it cannot automatically be applied or must be adopted by Indonesia, because a policy which is constitutional pursuant to the Constitution of a state, is not necessarily constitutional according to the 1945 Constitution, and vice versa;

[3.15] Considering whereas to support its statement, the Government presented two experts whose statements have been heard under oath at the hearing on February 4, 2009 along with their written statement as entirely included in the Facts of the Case part, which principally state as follows:

1. Prof. Dr. Zudan Arif Fakrulloh, S.H., M.H.

- The logic of the Constitution (the 1945 Constitution) is concerned with the presidential system and delegation of arrangement concerning the Presidential General Election and Legislative General Election to law with the strategy of strengthening the

presidential system through the development of simple party system, a democratic General Election system with effective strengthening of the representative institutions. The policy concerning the Parliamentary Threshold is a part of strategies of political development in the context of strengthening the presidential system through the three intended designs;

- The policy concerning the Parliamentary Threshold stipulated in Article 202 paragraph (1) of Law 10/2008 is not discriminatory, since it provides the same treatment and opportunity to all Political Parties Participating in the General Election. Similarly, different policy implemented on the Regional People's Legislative Assembly which is not subject to the provision of Parliamentary Threshold [*vide* Article 202 paragraph (2) of Law 10/2008], is not a discriminatory policy, since there is indeed different principle between the People's Legislative Assembly and the Regional People's Legislative Assembly, hence different policies can also be applied;

2. Dr. Lili Romli, M.Si.

- The policy on Parliamentary Threshold included in Article 202 paragraph (1) of Law 10/2008 is formulated in the context of creating a simple party system in order to strengthen the presidential system, because it is evident that the previous policy,

namely the electoral threshold, has failed to create a simple multi-party system;

- Through the policy on Parliamentary Threshold, the Political Parties Participating in the General Election which do not fulfill the threshold of 2.5% cannot position their representatives in the People's Legislative Assembly, so the number of effective political parties in the People's Legislative Assembly is relatively small;

Opinion of the Court

[3.16] Considering whereas with regard to the Principal Issue of the Petition argued by the Petitioners along with supporting evidence, as well as the conclusions presented, statement of the People's Legislative Assembly, statement of the Government, statement of the experts, and conclusion of the Government, the Court shall first convey the following matters before evaluating and providing opinion on the principal issue of the *a quo* petition:

- a. Whereas as of the 1999 General Election and followed with the 2004 General Election, the legislators, through Law Number 3 Year 1999 regarding General Election (hereinafter referred to as Law 3/1999) and Law Number 12 Year 2003 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly (hereinafter referred to as Law 12/2003) have adopted the policy on threshold for the seat or vote

acquisition percentage of Political Parties Participating in the General Election so as to be able to participate in the following General Election in Indonesia which is commonly known as “Electoral Threshold” (referred to as ET). The ET policy is expected to be able to create a simple party system as intended by Law Number 2 Year 1999 which was subsequently superseded with Law Number 31 Year 2002 regarding Political Party. As a result of such policy, in the 1999 General Election, there were only six Political Parties fulfilling the Electoral threshold and in the 2004 General Election, there were only seven Political Parties fulfilling the Electoral Threshold. While in order to participate in the subsequent General Election, Political Parties failing to fulfill the Electoral Threshold must established a coalition with other Political Parties fulfilling the Electoral Threshold or failing to fulfill the Electoral Threshold so as to meet the Electoral Threshold in accordance with the provision stipulated in Law 12/2003. Even though as a result of the establishment of new Political Parties or the metamorphosis of former Political Parties into new Political Parties, the number of Political Parties is still substantial but due to the Electoral Threshold policy set forth in Law 3/1999, the number of Political Parties Participating in the 2004 General Election decreased up to 50% of the total 48 Political Parties in the 1999 General Election to 24 Political parties in the 2004 General Election, while there were 16 Political Parties obtaining seats in the People’s Legislative Assembly in the 1999 General Election and 21 Political Parties in the 2004 General Election;

- b. With regard to the foregoing Electoral Threshold policy, the Court had once decided upon a petition for judicial review of the Electoral Threshold policy included in Article 9 paragraph (1) of Law 12/2003 filed by 13 Political Parties Participating in the 2004 General Election which did not fulfill the Electoral Threshold (some of those Political Parties also file a petition in Case Number 3/PUU-VII/2009) with similar arguments and by way of presenting experts who in fact recommended the Electoral Threshold to be replaced with Parliamentary Threshold. The Court decided to declare the petition as rejected with considerations, among other things, that the Electoral Threshold policy was not discriminatory as it was applied to all Political Parties, and constituted a legal policy mandated by Article 22E paragraph (6) of the 1945 Constitution which is very open in nature, namely that "*Further provisions on general elections shall be set forth in a law*", so that according to the Constitutional Court, both the policies on Electoral Threshold and Parliamentary Threshold were constitutional (*vide* Decision Number 16/PUU-V/2007 dated October 23, 2007);
- c. Whereas the Electoral Threshold policy adopted in Law 3/1999 and Law 12/2003 which by Law 10/2008, was subsequently substituted with a new policy known as "Parliamentary Threshold" (referred to as PT) stipulated in Article 202 paragraph (1) of Law 10/2008 which reads, "*Political Party Participating in the General Election shall be obligated to fulfill the*

threshold of vote acquisition of at least 2.5% (two point five percent) of the number of valid votes at national level so as to be involved in the determination of seat acquisition in the People's Legislative Assembly."

Through this Parliamentary Threshold policy, it seems that the legislators (the People's Legislative Assembly and the Government) intend to create a simple party system by way of reducing the number of Political Parties qualified to position their representatives in the People's Legislative Assembly. This is different from the method previously used by applying the Electoral Threshold which intended to reduce the number of participants in the General Election;

- d. Whereas to evaluate whether or not the Parliamentary Threshold policy stipulated in Article 202 paragraph (1) of Law 10/2008 is constitutional, it is necessary to first review the normative provisions concerning General Election included in Article 22E of the 1945 Constitution, as follows:

Paragraph (1) : *"General elections shall be held in a direct, public, free, secret, honest and fair manner once in every five years."*

Paragraph (2) : *"General elections shall be held to elect members of the People's Legislative Assembly, the Regional Representative Council, the President and Vice President, and the Regional People's Legislative Assembly."*

Paragraph (3) : *“Participants in the general elections for electing members of the People’s Legislative Assembly and the Regional People’s Legislative Assembly shall be political parties.”*

Paragraph (4) : *“Participants in the general elections for electing members of the Regional Representative Council shall be individuals.”*

Paragraph (5) : *“General elections shall be administered by a national, permanent and independent general elections commission.”*

Paragraph (6) : *“Further provisions on general elections shall be set forth in a law.”*

The provisions of Article 22E of the 1945 Constitution indicate that the Constitutional norms for the General Election are as follows: a) The General Elections are to be held in a periodical basis once in every five years; b) the General Election adopts the principle of direct, public, free, secret, honest and fair general election; c) the purpose of General Elections is to elect members of the People’s Legislative Assembly, the Regional Representative Council, the Regional People’s Legislative Assembly, as well as the President and Vice President; d) the participants in the General Elections to elect members of the People’s Legislative

assembly and the Regional People's Legislative Assembly are political parties, while the participants in the General Elections to elect members of the Regional Representative Council are individuals, and e) the General Election administrator is a national, permanent and independent general elections commission. Hence, the 1945 Constitution delegates the authority to freely set forth further provisions related to the General Elections, such as those concerning the General Election system, Electoral Districts, requirements to participate in the General Elections, the right to vote, et cetera, in a law as legal policy of the legislators, certainly insofar as they do not negate the principles contained in the 1945 Constitution, such as the principle of people's sovereignty, principle of equality, principle of justice, and the principle of non-discrimination;

[3.17] Considering whereas in the event that the Court in Decision Number 16/PUU-V/2007 dated October 23, 2007 deems that the policy concerning the Electoral Threshold adopted in Law 12/2003 as constitutional to serve as the legal policy of the legislators who obtain delegation from the 1945 Constitution, the Court shall subsequently evaluate the constitutionality of the Parliamentary Threshold policy stipulated in Article 202 paragraph (1) of Law 10/2008 by way of considering the Petitioners' arguments as follows:

- a. Whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 is contradictory to the principle of people's sovereignty stipulated in Article 1 paragraph (2) of the 1945 Constitution. According to the Court,

such matter is incorrect, because whether or not a Political Party Participating in the General Election is succeeded in complying with the provision on Parliamentary Threshold in the *a quo* article is fully determined by the people through the General Election, rather than by the People's Legislative Assembly and the Government;

- b. Whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 is contradictory to the principle of constitutional state stipulated in Article 1 paragraph (3) of the 1945 Constitution. According to the Court, the argument presented by the Petitioners is also incorrect, since the policy concerning the Parliamentary Threshold contained in the *a quo* article is based on law, *in casu* Law 10/2008, which was formulated in democratic manner by the People's Legislative Assembly and the Government, as well as does not violate the Human Rights (HAM), and in fact, it still guarantees the right of the Political Parties Participating in the General Election to exist as well as equal opportunities to participate in the subsequent General Election;
- c. Whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 violates the principle of equal position before the law and government stipulated in Article 27 paragraph (1) of the 1945 Constitution, because according to the Petitioners there are unequal treatments for the candidate members of the People's Legislative Assembly nominated by Political Parties which are subject to the policy of

- Parliamentary Threshold in order to position their representatives in the People's Legislative Assembly, while such provision is not applied for the determination of seats for members of the Regional People's Legislative Assembly at province level and the Regional People's Legislative Assembly at regency/municipality level. With regard to the argument presented by the Petitioners, the Court is of the opinion that such policy is appropriate, since the position of the Regional People's Legislative Assembly in the constitutional system is indeed different with that of the People's Legislative Assembly which is at the national level and holds the power to formulate laws [Article 20 paragraph (1) of the 1945 Constitution]. It also serves as a balance of the President's power in checks and balances system, moreover, the power of the Regional People's Legislative Assembly as part of regional government still can be controlled by the (central) Government. In this matter, the Court agrees with the arguments presented by the People's Legislative Assembly, Government, and experts of the Government, that the provision on Parliamentary Threshold which is only applicable for the determination of seats in the People's Legislative Assembly and not for the determination of seats in the Regional People's Legislative Assembly, is not a discriminatory policy, but rather a proportional policy;
- d. Whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 violates the provision of Article 28D paragraph (1) of the 1945 Constitution which reads, "*Every person shall have the right to the*

- recognition, the guarantee, the protection and the legal certainty of just laws as well as equal treatment before the law”* and is also contradictory to Article 28D paragraph (3) of the 1945 Constitution which reads, *“Every citizen shall have the right to obtain equal opportunities in government.”* According to the Court, the policy on Parliamentary Threshold policy stipulated in Article 202 paragraph (1) of Law 10/2008 absolutely does not disregard the principles of Human Rights contained in Article 28D paragraph (1) and paragraph (3) of the 1945 Constitution, since every person, every citizen, and every Political Party Participating in the General Election is treated equally and obtains equal opportunity through democratic competition in the General Election. Indeed, there is a possibility that there are parties which are succeeded and failed in a competition referred to as General Election, but the chance and opportunity remain equal;
- e. Whereas the Petitioners argue that Article 202 paragraph (1) of Law 10/2008 is discriminatory and irrational, so that it is contradictory to Article 28I paragraph (2) of the 1945 Constitution which reads, *“Every person shall have the right to be free from discriminatory treatment on any basis whatsoever and shall have the right to obtain protection against any such discriminatory treatment.”* With regard to such argument, the Court is of the opinion that the provision of Article 202 paragraph (1) of Law 10/2008 absolutely does not contain discriminatory nature and elements, since it is only applied objectively to all Political Parties Participating in the General

Election and the entire candidate members of the People's Legislative Assembly from the Political Parties Participating in the General Election without any exception, but also that there are no factors of discrimination of race, religion, gender, social status, et cetera as intended by Law Number 39 Year 1999 regarding Human Rights and International Covenant on Civil and Political Rights (*ICCPR*);

[3.18] Considering whereas, according to the Court, the arguments presented by the Petitioners regarding the unconstitutionality of Article 202 paragraph (1) of Law 10/2008 are not sufficiently grounded and *mutatis mutandis*, there are also no grounds to declare the articles related to Article 202 paragraph (1), namely Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 of Law 10/2008 as unconstitutional. According to the Court, if compared with the policy of Electoral Threshold provided for in the previous law on General Election, namely Law 3/1999 and Law 12/2003, which jeopardizes the existence of Political Parties and their opportunity to participate in the next General Election, the policy of Parliamentary Threshold stipulated in Article 202 paragraph (1) of Law 10/2008 is in fact provides more guarantee for the existence of Political Parties Participating in the General Election and their participation in the next General Election, as stipulated in Article 8 paragraph (2) of Law 10/2008 which reads, "*Political Parties Participating in the previous General Election may participate in the next General Election.*" The elucidation of Article 8 paragraph (2) reads, "*Referred to as the "previous General Election" shall be as from the 2009 General Election and the next general elections.*"

[3.19] Considering whereas therefore it can be concluded that the legislative institution may determine the threshold as legal policy for the existence of Political Parties whether in the form of Electoral Threshold or Parliamentary Threshold. The constitution allows this type of policy as politics with regard to the simplification of party system since in principle, the existence of related laws regarding Party System or Politics is indeed intended to create restrictions insofar as justifiable by the constitution. Whereas it is the authority of the legislators to determine the number of threshold without being interfered by the Court insofar as it is not contradictory to the political right, people's sovereignty, and rationality. Similarly, according to the Court, the provision regarding the existence of Parliamentary Threshold as regulated in Article 202 paragraph (1) of Law 10/2008 does not violate the constitution as the provision of the *a quo* law not only has given opportunity for every citizen to establish a political party but also for a political party to be selected and restricted rationally through the provision of Parliamentary Threshold to be able to position its representative in the People's Legislative Assembly. Anywhere in this world the constitution always grants authority to legislators to stipulate restrictions in laws for the execution of political rights of the people.

[3.20] Considering whereas even though the Court is of the opinion that the policy of Parliamentary Threshold stipulated in Article 202 paragraph (1) of Law 10/2008 is as constitutional as the policy of Electoral Threshold policy provided for in Law 3/1999 and Law 12/2003, the Court deems that the

legislators are not consistent with their policies concerning the General Election and appeared to be continuously experimenting and still do not have a clear design as to what is intended as the simple party system they want to create. Thus, every time the General Election is approaching, it is always followed with the formulation of new laws in the field of politics, namely law regarding Political Parties, law regarding General Election, and law regarding the Structure and Position of the People's Consultative Assembly, the People's Legislative Assembly, Regional Representative Council, and the Regional People's Legislative Assembly;

4. CONCLUSION

Based on the foregoing considerations of facts and laws, the Court concludes that:

[4.1] Article 202 paragraph (1), Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 of Law Number 10 Year 2008 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly (State Gazette of the Republic of Indonesia Year 2008 Number 51, Supplement to the State Gazette of the Republic of Indonesia Number 4836) are not contradictory to Article 1 paragraph (2) and paragraph (3), Article 27 paragraph (1), Article 28D paragraph (1) and paragraph (3), and Article 28I paragraph (2) of the 1945 Constitution of the Republic of Indonesia;

[4.2] The arguments of the Petitioners are not sufficiently grounded to be granted;

5. **DECISION**

Based on the 1945 Constitution of the Republic of Indonesia and in view of Article 56 paragraph (5) of Law Number 24 Year 2003 regarding Constitutional Court (State Gazette of the Republic of Indonesia Year 2003 Number 98, Supplement to State Gazette of the Republic of Indonesia Number 4316);

Passing the decision,

Declaring to reject the Petitioners' petition in its entirety.

Hence the decision was made at the Plenary Consultative Meeting attended by eight Constitutional Court Justices on Thursday, the fifth of February two thousand and nine and was pronounced in a Plenary Session of the Court open for the public on Friday, the thirteenth of February two thousand and nine by us, eight Constitutional Court Justices, namely Moh. Mahfud MD, as the Chairperson and concurrent Member, Abdul Mukthie Fadjar, Maria Farida Indrati, Muhammad Alim, Achmad Sodiki, M. Akil Mochtar, Maruarar Siahaan, and M. Arsyad Sanusi, respectively as Members and assisted by Makhfud as Substitute Registrar, in the presence of the Petitioners and/or their Attorneys, the Government and/or its Attorneys, and the People's Legislative Assembly and/or its Attorneys.

With regard to the foregoing Court's Decision, there are two Constitutional Court Justices having dissenting opinions, namely Maruarar Siahaan and M. Akil Mochtar, as follows:

1. DISSENTING OPINIONS

[6.1] **Constitutional Court Justice Maruarar Siahaan**

It is stated that Article 202, Article 203, Article 205, Article 206, Article 207, Article 208 and Article 209 of Law Number 10 Year 2008 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly related to the parliamentary threshold (PT) being petitioned for review, constitute a legal policy formulated by the legislators as a politic development strategy in the context of strengthening the presidential system through simple multi-party system, democratic General Election system, and effective strengthening of representative institutions. However, all policies, whether in form of laws and regulations or in form of implementation actions, must carefully and thoroughly take into account the norms, soul, and spirit of the constitution contained in the 1945 Constitution;

In my opinion, Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 of Law 10/2008 actually do not take into account and carefully consider the norms, soul, and spirit of the constitution in the 1945 Constitution, which should become the source of legitimacy for all the products of laws and regulations legislated. The policy is also clearly adopted by trial and error, which constitutes the amendment to Law Number 12 Year 2003 regarding the General Election of Members of the People's Legislative Assembly, the Regional Representative Council, and the Regional People's Legislative Assembly using electoral threshold as mechanism for the party simplification, which had been changed into parliamentary threshold and a number of other

thresholds, before it is applied. Accordingly, a strong impression that momentarily interests highly affect the policy created is unavoidable, and that the policy is not strictly reviewed with the principles of the constitution, which should be complied with and protected as well as fulfilled by the legislators (Obligation to protect, to guarantee and to fulfill);

Article 1 paragraph (2) of the 1945 Constitution serving as the basic norm to be firmly held in the life as a state has affirmed that the sovereignty is in the hands of the people, and the implementation must be based on the 1945 Constitution, which reflects the form of the State of Indonesia as a democracy state based on constitution (constitutional democracy). Hence, its descriptions in the government design and General Election design in the framework of democracy and constitution which are expected to create an effective government system through the entire laws and regulations required, must be made in the context of protecting, guaranteeing, and fulfilling the basic rights of the citizens, which can only be reached by way of carefully considering and taking into account the norms of the constitution. The pragmatic attitude which is highly situational and allowing all systems deemed to be suitable must be avoided, as it will result in the *constant changing* of policies according to the desire of the decision makers;

People's sovereignty serving as the source of legitimacy of all provisions of laws and regulations regulating the general election and all designs made must be implemented in accordance with the 1945 Constitution, no matter

how difficult it is. This obligates the legislators to always start from the basic principle that the highest power is in the hands of the people as citizens. Their human rights contained in the 1945 Constitution, are not a gift from the state or government, but naturally inherent in their own self. The human rights inherent in the holders of people's sovereignty, among other things, include the rights to elect and be elected in the context of participation in government which constitutes the right to improve themselves in striving for their rights collectively for building their society, nation, and state in equal or non-discriminatory treatment. A constitutional democratic state guarantees equal opportunity for citizens to participate in determining the government direction and policy in order to put into realization the purposes of the state outlined, even though such matter may not always be implemented directly, but rather through representation system;

Article 202 of Law 10/2008 which is closely related to Article 203, Article 205, Article 206, Article 207, Article 208, and Article 209 of Law 10/2008, basically stipulates the threshold of 2.5% (two point five percent) of the valid votes at national level to be included in the determination of seat acquisition in the People's Legislative Assembly, **truly disregards the principle of people's sovereignty** used by the voters to elect their representatives in the People's Legislative Assembly, but it is not made as benchmark for the Regional People's Legislative Assembly. This is conducted with an excuse that to simplifying the political parties existing in the People's Legislative Assembly as one of the strategies of the strengthening of presidential system. The issue of simplification

of political parties in the parliament as a strategy of strengthening of presidential system is a disproportionate instrument if compared with the weight of people's sovereignty and human rights in the constitution, which should serve as the source of legitimacy of the strategy concerned. The principle of representation stated in the form of the votes granted as people's sovereignty, must be separated from the issue with regard to party as determinant factor, which for the people, it has actually been settled when the candidates recruited by them are finally nominated and elected. The representation of voters to participate in the policy of state and nation at national level which has been guaranteed by the 1945 Constitution, cannot be set aside only because there is a strategy selected through certain thresholds. The method selected must be implemented in such a way that the amount of threshold only pertains to the related political party, rather than to the representativeness which has become the choice of the holders of people's sovereignty. It is evident that this matter is diametrically contradictory to the people's sovereignty and human rights which are expressly referred to in Article 1 paragraph (2), Article 27 paragraph (1), Article 28C paragraph (2), and Article 28D paragraph (3) of the 1945 Constitution;

Even though the argument presented by the Government in the Written Conclusion is correct, that Article 22E paragraph (6) of the 1945 Constitution delegates the authority to further set forth the General Election to the legislators and Article 28J paragraph (2) of the 1945 Constitution stipulating the rights and freedom of citizens to comply with the restrictions provided for by law, however Article 28J paragraph (2) of the 1945 Constitution also expressly states

that the restriction is only imposed by such law with a **sole purpose** to, *“guarantee the recognition of and the respect for other persons’ rights and freedom and fulfill fair demand in accordance with the considerations of morality, religious values, security, and public order in a democratic society”*;

Actually Article 28J paragraph (2) of the 1945 Constitution also includes a benchmark which can be traced back to the principle of the constitution, namely proportionality, which also constitutes the main principle required by the principle of rule of law. Such principle is a benchmark to be used all the times as a ground for justification, of whether the restriction imposed through law legislated could justify the restriction to the right of democracy or people’s sovereignty and human rights. The three benchmarks to be fulfilled in applying the principle of proportionality to the restriction of basic rights of citizens to be considered as valid and not in contradictory to the constitution are as follows:

1. The law restricting the human rights constitutes a proper effort for accomplishing a purpose;
2. The instrument used to restrict such right and freedom is required so as to achieve a legal purpose stipulated;
3. Burden on the foregoing restricted right must be proportional or equal to the benefits guaranteed by such law.

In my opinion, the Court has not strictly conducted the measurement concerned before granting justification on the restriction of people's sovereignty and human rights of the citizens as contained in the *a quo* law, and in addition, the purpose and instrument to be achieved are **disproportionate** to people's sovereignty which serves as the state foundation and the human rights guaranteed by the constitution. The design of government system and implementation of General Election in democracy pursuant to the constitution still requires a more serious alternative reasoning so that the State of the Republic of Indonesia is able to become a dignified state. Since it is only when the human rights of every person is respected, can we uphold the people's sovereignty as mandated by the 1945 Constitution (Franz Magnis-Suseno: 2001). In fact, this is the main duty of the Court, as has also been outlined in its vision, namely "*The enforcement of constitution in the context of realizing the purpose of constitutional state and democracy for the sake of dignified life as a nation and a state*";

Based on all the foregoing descriptions, I have opinion that the articles concerning the Parliamentary Threshold in the *a quo* law are contradictory to the 1945 Constitution, and should be declared as having no binding legal effect.

[6.2] **Constitutional Court Justice M. Akil Mochtar**

Whereas the 1945 Constitution has laid down the "principle of people's sovereignty" to become the "main principle of the constitution" and also

as the “morality of the constitution” which are not only giving spirit, nuance and influence in stipulating various forms of laws and regulations in the politics, but also a “distinctive characteristic and shade” to the form of government;

General Election as a democratic facility in the context of realizing the “principle of people’s sovereignty” must be rested upon the amount of votes cast by the people for their representatives. Whereas the extent of mandate given by the people to the elected candidates indicates a strong political legitimacy toward the related candidates, thus the strong legitimacy acquired from the people will automatically strengthen the accountability which will more easily aggregate the will of the people represented by them;

Whereas strengthening the presidential system and establishing a simple party system are a certainty which is not only creating a stable government and intends to produce a strong parliament institution, but more than that, the democracy system we wish to reach is how a comprehensive equitable democracy which protects the entire Indonesian nation and native land can strengthen the structure of the Unified State of the Republic of Indonesia as the noble desire of the nation of Indonesia provided for in the Preamble to the 1945 Constitution which reads, *“Indonesia's National Independence shall be enshrined in the Constitution of the State of the Republic of Indonesia, established within the structure of the State of the Republic of Indonesia with the sovereignty of the people based upon Belief in The One and Only God, just and civilized Humanity, the Unity of Indonesia, and Democracy guided by the inner wisdom of*

deliberations amongst representatives, and by creating social Justice for all the people of Indonesia”;

Whereas the concept to create a strong presidential system and the concept to build a simple party system are the jargons repeatedly made as strong grounds in every law in the political field, including in the General Election Law, as from Law Number 3 Year 1999 regarding General Election, Law Number 12 Year 2003 regarding the General Election of Members of the People’s Legislative Assembly, Regional Representative Council, and Regional People’s Legislative Assembly until Law Number 10 Year 2008 regarding the General Election of Members of the People’s Legislative Assembly, Regional Representative Council, and Regional People’s Legislative Assembly by utilizing legal policy as choice for legislators. However, such matter has not been conducted correctly and consistently when applying the threshold policy of seat acquisition with the electoral threshold model which always changes in every five-year cycle of the implementation of Legislative General Election. As a result, such inconsistency has also greatly contributed to the non-achievement of the simple party system and strong government intended to be materialized by the legislators themselves;

In my opinion, the choice of the legislators in stipulating legal policies including, among others, issues related to the choice regarding the threshold set forth in various laws and regulations in the political field for the grand concept (grand design) of political development as an effort for conducting

consolidation of democracy for the establishment of a strong presidential system and a simple party system, must carefully consider all the norms, soul, and spirit contained in the 1945 Constitution, which have confirmed the State of Indonesia as “nomocratic” state, which basically contains two main substances. *Firstly*, as the concept of rule of law state, that the authority of law universally surmounts the state power, and accordingly, the law will control politics, not otherwise. *Secondly*, the concept of civil rights of citizens stating that, “the freedom of citizens shall be guaranteed by the constitution and the state power shall also restricted by the constitution, and such power also shall only obtains its legitimacy from the constitution “;

Democracy is an institutional planning to reach a political decision where individuals obtain power to decide upon the means of competitive struggle for people’s votes (Joseph A. Schementer);

Democracy constitutes a government system where governments are required to account for their actions in the public domain by the citizens acting directly through the competition with their elected representatives (Philippe C. Schmitter and Terry Lynn Karl);

Democracy as a political system constitutes a system indicating that public policy is stipulated based on the majority principle by the representatives supervised effectively by the people in periodical elections based on the principle of political equality and held in the atmosphere of guaranteed freedom (Henry. B. Mayo);

Affan Gaffar (2000) explains democracy in two forms, namely normative and empirical interpretations. Normative democracy is a democracy which is ideally intended to be performed by a state, while the empirical democracy is a democracy as manifested in practical politics;

Hence, based on the foregoing opinions, democracy basically constitutes the social and state life system, as well as government emphasizing the existence of power in the hands of the people having meanings as follows:

1. Government from the people;
2. Government by the people;
3. Government for the people.

In my opinion, the use of threshold in building the mechanism for the simplification of political parties, namely the use of electoral threshold and parliamentary threshold namely the two models of application of threshold of seat or vote acquisition percentage for political parties participating in the general election have brought about different impacts on the election of legislative members in the parliament which is not in line with the simple party system as well as the institutional strengthening of the People's Legislative Assembly;

The electoral threshold system has made political parties participating in the general election unable to reach the vote acquisition in accordance with the threshold stipulated by the law, such political party would not

automatically become a participant in the subsequent general election, even though such political party is able to place its representatives in the institution of the People's Legislative Assembly. Meanwhile, the parliamentary threshold results in the non-election of a candidate member of the People's Legislative Assembly even though its vote acquisition perfectly surpasses the threshold stipulated based on the value of a seat in the Electoral District (*Dapil*) which actually also constitutes the threshold at the Electoral District level, but the party would continue to become a participant in the subsequent general election;

When taking into account Law 10/2008 using Open Proportional General Election System, this system gives an appreciation of the people's votes to openly and freely elect and determine the legislative members. This system also eliminates the action of neglecting the casting of people's votes in vain as well as guaranteeing the "principle of representation" based on the respect for minority groups in the Indonesian plural society;

Through its decision Number 22-24/PUU-VI/2008 dated December 23, 2008, the Court in its legal consideration has also expressly stated to guarantee the fulfillment of the "principle of people's sovereignty" and the "principle of representation" with the consideration which reads, "*... hence, the electability of the legislative candidate members shall not shift from the decision of the sovereign people to the decision of the political party administrators as the mandate of the constitution provided for in the Preamble to the 1945 Constitution*";

Whereas Article 202 of Law 10/2008 affirming the “principle of parliamentary threshold” has discriminatory given unequal treatment to the same principles. Why? Because it only applies to the election of members of the People’s Legislative Assembly, but does not apply to the election of members of the Regional People’s Legislative Assembly at the Province/Regency/municipality level. Since all the implementation stages of general elections regulated in Article 4 paragraph (2) of Law 10/2008 equally apply both to political parties participating in the general elections and legislative candidate members, even though they pass the same process, at the stipulation of final result, different provisions are applied;

Similarly, when Article 202 of Law 10/2008 is reviewed, the *ratio legis* and consistency are unclear. This matter also indicates that it has no relevance with the desire to build a Simple Party System as well to strengthen the legislative institution in a strong presidential system. Such matter has given unequal treatment and also created legal uncertainty and injustice in contradiction to Article 28D paragraph (1) of the 1945 Constitution;

Hence, the principle contained in Article 22E paragraph (1) of the 1945 Constitution for the implementation of general election to have high quality with participation of people to the greatest possible extent on the basis of democratic principles namely direct, public, free, secret, honest, and fair general election must become the main ground for the implementation of general election to be developed and implemented by the General Election Law in a brief and

simple manner to serve as the ground for all stages of general elections to be accounted for, where the people as the “main subjects” in the “principle of people’s sovereignty” are not placed only as an “object” by the stakeholders by merely putting into realization the principle of victory because a strong presidential system with the model of party simplification as well as strong parliament is not built as easily as turning one’s hand but that it requires consistency and sufficient time to be conducted gradually by all components of the nation for the sake of the integrity and establishment of the Unitary State of the Republic of Indonesia that we love. Hence, in my opinion, Article 202 of Law 10/2008 regarding parliamentary threshold is contradictory to the 1945 Constitution and it should have been declared to have no binding legal effect.
