## JAKARTA DECLARATION ON THE ESTABLISHMENT OF THE ASSOCIATION OF ASIAN CONSTITUTIONAL COURTS AND EQUIVALENT INSTITUTIONS

We, the Presidents and Heads of the Asian Constitutional Courts and Equivalent Institutions of the Republic of Indonesia, the Republic of Korea, Malaysia, the Republic of Mongolia, the Republic of the Philippines, the Kingdom of Thailand and the Republic of Uzbekistan,

**CONSIDERING** that the Constitutional courts and equivalent institutions have an important role to play in ensuring the rule of law for the implementation of basic constitutional rights and individual freedoms;

**RECOGNIZING** the need to enhance close cooperation among them for the promotion of the rule of law, democracy and human rights through the exchanges of experiences and information on constitutional cases and jurisprudence;

**REAFFIRMING** our common understanding to build partnership through sharing information and best practices on constitutional cases for the progress of democracy and the promotion of human rights in Asia on the basis of mutual respect and judicial independence;

**CONVINCED** that the establishment of an Association of Asian Constitutional Courts and Equivalent Institutions will greatly foster such cooperation;

**RECALLING** the Memorandum of Understanding to establish the Asian Conference of Constitutional Courts adopted in Ulaanbaatar, Mongolia, on 8 September 2005;

HAVING CONSIDERED the Statute of Association of Asian Constitutional Courts and Equivalent Institutions as finalized by the 3rd Meeting of the Preparatory Committee for the Establishment of the Association of Asian Constitutional Courts and Equivalent Institutions in Seoul, the Republic of Korea, on 8 April 2010;

## DO HEREBY DECLARE:

- 1. **TO ADOPT** the Statute of the Association of Asian Constitutional Courts and Equivalent Institutions, the text of which is attached hereto;
- 2. TO OFFICIALLY LAUNCH the Association of Asian Constitutional Courts and Equivalent Institutions ("the Association") as an independent and non-political forum for members of constitutional courts and equivalent institutions to exchange experiences and information on shared concern on constitutional cases and jurisprudence for the promotion of the rule of law, democracy and human rights;
- TO CONVENE the inaugural congress of the Association of Asian Constitutional Courts and Equivalent Institutions be held in the Republic of Korea within the next two years.
